The directive 2002/96/CE dated 27/01/03 ("WEEE") applies to low voltage products, listed in annex IA. That directive wants to avoid, reduce, reuse as well to recycle electrical and electronics old units. Stationary machines and their components and assemblies which are not independent units are exemptions for this directive. Our products fulfil at least one of these mentioned facts, therefore they are not concerned in WEEE directive.



The European Union issued the directive 2002/95/CE ("RoHS") to reduce the use of certain hazardous substances in electrical and electronic equipment. This directive is valid for the EU member states.

All our products fall under the exemption which applies to **product category 9 "electronic equipment"**; because they are considered components of a stationary machine.

May 2006: 90% of ROTACOD, DRIVECOD & POSICONTROL products to be RoHS/WEEE compliant
Dec. 2006: all catalogue products to be RoHS/WEEE compliant except running out products*

DIRECTIVES 2011/65/EC (RoHS II) and 2002/96/CE (WEEE)

In June 2011 the European Union issued the new directive 2011/65/EC ("RoHS II"), replacing the previous one 2002/95/EC (RoHS I) on the restriction of the use of certain hazardous substances in electrical and electronic equipment. This directive is valid for the EU member states.

The new Directive 2011/65/EC deals with the same hazardous substances and the same maximum concentration limit as RoHS I, but is expanded to previously excluded categories.

Therefore, conscious about the importance of the environmental protection and the preservation of the natural resources, we are committed to guarantee that our products comply with the above mentioned directives.

For this reason, we implemented all due activities in order to restrict the use of hazardous substances in our products.

Not all our compliant products will be marked with "WEEE" and "RoHS" logos. Customers can recognize a conform product from the date it has been introduced on the market. The serial number on each product label contains the date of manufacturing.
